CORRIGENDUM

1. Amendment in Buyer-Added Bid Specific ATC Section

Clause No. 30 — *"In case two or more than two bidders quote the same service charges, L-1 will be decided by Run L1 feature of GeM."*

➡ **This clause stands deleted in its entirety.**

Revised Status:

The evaluation and determination of **L-1 bidder** shall be made as per the applicable provisions of the **GeM portal** and **ICMR's QCBS evaluation criteria**, as detailed in the tender document.

2. As per ICMR Model Tender Document (Ref: No. ICMR/CPC/2023-24/EOI-HREmpanel/07 dated 19.09.2023)

Page 10, Clause 4.3 – Service Assumptions

To be read and included as follows:

(a) The engagement of human resources for different projects of the Buyer (ICMR) is on a **skill development program** and with **fixed consolidated remuneration**. Hence, **ESI and EPF are not applicable** for the same.
