 - LAN Cable - D-Link/Astrum/Aliens/Equivalent.
- The quotation should be addressed to "The Director, ICMR-National Institute of Nutrition, Hyderabad".
- The offer/quotation in sealed cover should reach the undersigned by 17:00 Hrs. on or before 08-03-2026 along with **EMD ₹9800/-** as Demand Draft/Bankers Cheque/Pay Order of Scheduled Banks drawn in favour of THE DIRECTOR NIN payable at Hyderabad and hand over in the Dispatch Section/ Maintenance Department. The offer/quotation received thereafter will not be considered. ICMR-NIN, Hyderabad is not responsible for any postal delays. **Firm/Personal cheques will not be considered.**
- It is the responsibility of the contractor to visit the site before submitting their offer/quotation, for which the bidder may contact I/c Maintenance at 040-27197226/312 on all working days i.e., Monday to Friday except public holidays from 09:00 Hrs. to 17:30 Hrs.
- Quotation should be submitted in **Contractor's Letter Head with Signature in each page.**
- Certificate of Registration for Goods and Services Tax (GST).
- Percentage of tax (GST) and amount should be mentioned separately in the quotation.

- The work shall be completed within 30 days from the date of award of the work.
